COMMUNITY ENGAGEMENT

Life member, Sallie Parks, was honored May 7 at the Clearwater Historical Society's 2nd Annual Women's History Exhibit. Sallie was one of nine women recognized for contributing their time, talent and leadership to Clearwater and Pinellas County.

"The League was a door-opener in so many ways," she said. Sallie and her husband had just moved to Clearwater in 1964 when she commiserated to a friend that Florida required proof of one year's residence before being eligible to register to vote. "Well, you need to join the League," advised Mary Bourdreau. Sallie signed up, becoming president of our League 1972-74.

Sallie often attended meetings of the Pinellas County Commission and learned the issues. Later, at a League meeting, the presenter asked how many would be willing to run for office. Her hand shot up. She campaigned and was twice elected Pinellas County Commissioner, from 1992-2000. Among her many achievements, Sallie is a founding member of the Pinellas County Arts Council and the PACE Center for Girls in Pinellas. And those Silver Alerts? Thank Sallie for planting the seed.

"The League's stature has improved," she said, but laments it's harder for younger members with work and family responsibilities. Sallie credits the League's success to the fact that members study, observe and dig into issues. She hopes the League continues to educate voters about candidates and engage with the community as often as possible.



The League Supports S.1 The For the People Act. Here's Why;

The Senate plans to bring S.1 the *For the People Act* to a vote June 21 through June 25. Public interest organizations, including the League, Equal Citizens, the Brennan Center for Justice, Represent Us, End Citizens United, Common Cause, the Declaration for American Democracy Coalition, and Open Democracy, recommend we contact our Senators to ask them to support and pass the bill.

The League worked with members of Congress to shape key pieces of the *For the*

People Act, including expanding automatic voter registration, same day voter registration, and online voter registration.

Equal Citizens also created an open letter that people can sign on to support the act

and to obtain contacts of within supporting organizations. The Equal Citizen <u>video</u> joins Seinfeld's Jason Alexander, Harvard Law School's Lawrence Lessig, and the Brennan Center's Elizabeth Hira who was involved in writing the act, for a comprehensive conversation (and comedic questions) about the historic fair elections bill, one of the most important in generations.

- Your League's Advocacy Child Poverty Beth Hovind and Karen Owen recently teamed up to present "Child Poverty in Florida" to the LWVFL State Convention and to ASPEC, the Academy of Senior Professionals at Eckerd College. Beth contributed her many decades of experience working to eliminate child

poverty in the US and Karen contributed her geospatial skills. Listen to the audio recording here. Here we publish Part 1 of a 3 part overview of child poverty.

PART 1, by Beth Hovind: My introduction to child poverty began 46 years ago in my first job as a child welfare worker for Portage County, Wisconsin. I got a call from a lowincome apartment unit about a child who was being sent to school underdressed during the cold winter. I knocked on the door and was met by a woman who angered quickly when I told her why I was there. She proceeded to tell me her story; she was unable to $\,$ work and had to survive on welfare: "I am left with just bad choices—either I can keep my daughter warm or I can keep her fed. I do not have enough money to do both. What do you want me to do?" I had no good answer. A second woman was reported to child welfare for not having working plumbing in her trailer, risky and unsanitary. During a home visit, I learned that with almost no money, this was the only place she could find to live--at least they had heat-- and she could bring in water if necessary. Not the best, but deserving of having a child removed? In a third instance, one of my clients, a young mother, rode her bike 14 miles to the office to pick up the month's allotment of food stamps only to be denied the stamps because she had no money. In those days, the system believed that people would value a benefit more if they had to partially pay for it. She came to my office depressed and upset, not knowing that cash was required. The volunteer coordinator and I raided the coffee fund of \$10; she got her stamps, and she rode the 14 miles home. These were all families with limited resources trying to care for their children. These were problems caused by poverty-problems you and I will likely never face. Here are a few thoughts for reflection:


- "Poverty is the worst form of violence." Gandhi.
- "Work with the poor and incarcerated has persuaded me that the opposite of poverty is not wealth, the opposite of poverty is justice." Bryan Stevenson, author of "Just Mercy."
- "Overcoming poverty is not a gesture of charity. It is the protection of a fundamental human right, the right to dignity and a decent life." Nelson Mandela.
- "Poverty is like punishment for a crime you didn't commit." Eli Khamarow, author.


But poverty cannot be such a problem in our prosperous state, can it?

Yes! It is. Too many children in Florida today suffer from the ill effects of poverty that their parents cannot overcome; many of them live in single parent, female headed households.

Let's begin by concretely defining poverty: The national poverty standard for a family of 4 is \$26,246 which equates to \$12.86/Hr. for a full-time worker. According to the Florida Chamber of Commerce this means that 829,232 children in the state of Florida are living in poverty including 18.4% of all children under 5. Think of this: 1 in 5 children are growing up without their basic needs being met; 55% of children are living in or near poverty according to the Florida Children's Campaign. An extreme poverty rate means 8% of the population lives on less than \$2/day/person. Survival is a challenge!

Dr. Karen Owen has created maps of the counties of Florida showing the distribution of child poverty by county and by race that demonstrate the stark differences between children identified as Black or as White in the Census. Each of us can make a difference by volunteering at schools, providing resources to neighborhoods in need, and advocating for children and their families with state and national representatives.
