Annual Meeting and Luncheon, April 1, 2023



David Jolly, attorney, former congressman, lobbyist, speaker, author and political commentator gave the main address at the LWVNPC Annual meeting and luncheon on April 1 at Trinity Presbyterian Church, Clearwater. During a well-received presentation, he recognized the obstacles facing the LWV and other organizations committed to protecting democracy and empowering voters. He spoke of deliberate voter suppression efforts occurring in state legislatures across the country, the marginalization of already marginalized populations, and the attack on the media. He touched on gun violence, and that expecting our children to be safe at school is no longer a given. Yet he also pointed to the elections of 2018 and 2022, with the majority of the country rejecting the direction of the previous years and signaling a return to respecting our election process and saving democracy. He also addressed a question regarding the current political climate in Florida, which performed differently than the rest of the country.

Despite the improved horizon, there is much work to be done. Mr. Jolly called for fundamental election reform. Most importantly, Jolly spoke of voters putting aside strict adherence to party platforms, and instead forming coalitions that share values such as: protecting democracy, creating a superior education

system, making health care affordable and accessible, and creating policies that give all people equity and self-worth. Mr. Jolly ended with a salute to the LWV, saying that he was happy to speak at the LWWNPC luncheon, because "I stand in gratitude for the work you do."

The LWVNPC continues to collect petitions in support of getting the Right to Clean Water initiative on the 2024 ballot. Despite having a comprehensive body of state environmental laws and regulations, the condition of Florida waters continues to decline. If the measure to amend the state constitution passes, *“it creates a fundamental right to clean and healthy waters, clarifies prohibited actions and inactions that harm (or threaten to harm) waters, and defines important terms. It*

also allows Floridians to enforce this right through the ability to sue state executive agencies that violate this right.” This grassroots movement needs 900,000 petition signatures by November 2023 to get on the 2024 ballot. Please continue to educate yourself on this amendment and encourage others to sign the petition. Petitions must be signed manually and mailed, but each envelope may contain up to five petitions.

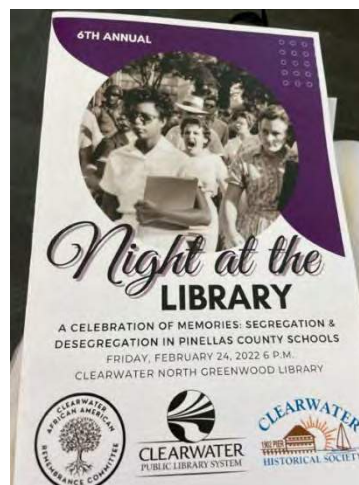

League of Women Voters Sides with Democracy.

Marti Folwell first became involved with the North Pinellas League of Women Voters more than 50 years ago. A neighbor encouraged her to come to a meeting, and babysitting was provided, so she decided to give it a try. "I met a lot of really interesting and well-educated people," she said. "So, I decided to join." Today she is still a member and is serving her third term as president of the organization. The League is a political grassroots network and membership organization that believes the freedom to vote is a nonpartisan issue. The North Pinellas group has over 100 members who work to expand voter access, influence public policy, educate both the public and legislators on issues of importance, and defend democracy. "It's a great opportunity for people to use their brains and advocate for issues that are of importance to them," Folwell said. Through different committees, members attend school board and other government meetings; travel to Tallahassee to educate and advocate on statewide issues of importance to the group; educate local citizens on public policy issues; hold candidate forums around elections; and work to encourage teenagers and others to register to vote and to participate in the voting process. Some current issues being supported by the League include protecting the environment, protesting against limiting what can be taught in history classes in public schools and fighting for fairness in voter redistricting.

Economic Equity Committee



The current focus has been on the state's legislative session, with a number of proposed bills focusing on reproductive rights, gender-affirming care and school curriculum addressing sex education, diversity, equity and inclusion.

The Heartbeat Bill, as it is called, has passed and will go into effect unless the Florida Supreme Court decides

on a challenge that the current 15-week abortion law is a violation of the Florida Constitution's guarantee of the right to privacy. South Carolina's Supreme Court did strike down a similar law for that reason. That state would become the closest state to which a Florida woman could travel to for a legal abortion after 6 weeks. The proposed law also provides \$25 million in taxpayer money to the Florida Pregnancy Care Network, which pushes alternatives to abortion. While the law adds some exceptions such as rape, incest and human trafficking, there must be documentation as evidence, creating additional hurdles for a woman and her physician. The court ruling is expected by summer.

Additionally, access to the abortion medication, Mifepristone, is being restricted to prescribing only through an in-person visit to a physician. We are awaiting impending action this week from the Federal Supreme Court on the recent federal judge in Texas ruling that the FDA-approved drug be taken off the market completely.

One positive bill moving ahead, the Learning With Dignity Act, makes menstrual products available to students in public school at no cost to students.

What is known as the Don't Say Gay bill has been amended to include a broader provision stretching to the 8th grade, and allowing schools to disregard students' choice of pronouns, even with parental support. Also, expect more legislation on gender-affirming care, sex education, coursework in schools, and control of faculty hiring.

The committee will begin planning for a hot topic on affordable housing in the county in June. Anyone interested in the issues around renter's rights, access and availability of affordable housing is encouraged to contact the committee at mharkins@QIS.net.

Education Committee



The Education Committee met virtually on Monday, March 27 th at 4:30 pm and welcomed new League member, Debbie Entreken.

Update on My Vote Counts Project: Vivian presented Part I of the My Vote Counts presentation during a virtual mentoring session for Take Stock in Children on Tuesday, April 11 th. There were 48 high school students in attendance. Part II will be presented on Tuesday, May 2nd. The Education Committee has been invited to participate in the virtual mentoring sessions again during the 2023-24 school year.

Unfortunately, district policy precludes our voter presentation to career and technical schools in Pinellas County. No outside groups are permitted to do voter registration.

Pinellas District School Board: Jeanne Reynolds has attended several Board meetings as a representative of the League. Vivian attended the April 11th meeting and found the sign-in process to be smooth. She was announced at the opening of the meeting as representing a community organization. The next School Board meeting is set for Tuesday, April 25, at 5:00 pm. Any member of the League is invited to attend as a representative of the League and a supporter of public schools.

Education Committee Hot Topic: "Why Public School is the BEST Choice": In response to the recent passage of HB1/SB202 (School Choice) that establishes a universal voucher program for all students who wish to attend a private school in Florida, the Education Committee has planned a virtual Hot Topic titled, "Why Public School is the BEST Choice." The date of this event is Wednesday, April 26 th (5:00 pm). Key information to be presented during this event includes the history of the School Choice movement in Florida, as it relates to public, charter, and private schools; the three parallel systems of

education that exist in Florida at this time; the fiscal impact on traditional public schools as a result of the proposed system of universal vouchers; and a description of some of the 80+ programs that are offered for Pinellas County students in grades K-12 in traditional public schools. Invited speakers include Dr. Sally Butzin, (LWV member and author of the Investigate Report on Step Up for Students); Caprice Edmond, Pinellas School Board Member; and Ellen Truskowski, Pinellas Director of the Student Assignment Office. The registration flyers are being sent this week to members of both Pinellas County Leagues, and other community and parent groups. Registration is required. <https://forms.gle/wckWYPLNx4N5d9vk8>

Want to Help Register Voters?

It's an important time for League members. If you wish to become more involved, why not become League-certified to facilitate voter registration, VBM, and getting out the vote? One has to pass an 18-question quiz to become certified.

Go to <https://lwvfl.org/>. Scroll down the page to a box that looks like this: Click on the League Management box to enter a page that has lots of boxes including the Register Voters box. Clicking once on the box will take you to a page requiring a password. Contact a member of the board for authentication details, or email lwvnpc.info@gmail.com.

Once the password is entered, you can read the 3 pages of training material and take the quiz repeatedly if necessary to score 100 percent on the quiz.

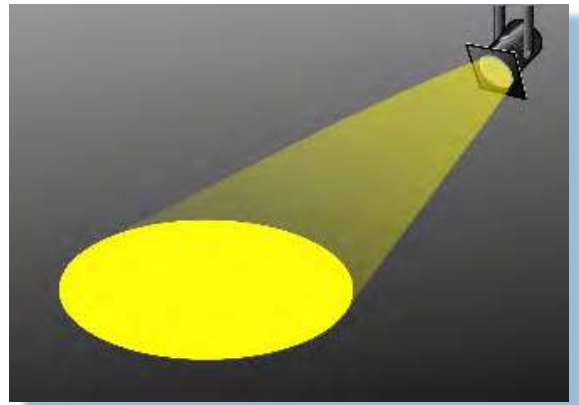
Then you are good to register voters with a certified partner under the League auspices for the next year.

Spotlight: Introducing Karen Owen



If the LWWNPC had a wizard, it would be Karen Owen. Karen is “conversant” in computers, website and social media management, audio-visual equipment, graphic design, and was the first one to arrange live streaming via Facebook of a



hot topic. She also does a lot of speaking and writing for the League, but perhaps her greatest attribute is her passion for the League’s mission.

To her, the LWW stands for democracy for all, not just the wealthy and well connected, and the right to vote is paramount. She has served as second Vice President and as a board member for the last two years. Karen reports that working with the League has given her confidence, leadership and advocacy skills, and the ability to navigate statutes and legislation. As Karen says: “Being part of the League of Women Voters, this trusted organization, has been so valuable to me and I hope to be a member forever.”

Karen moved to Florida from Northern Virginia in 2015 and joined the LWWNPC in 2016. In her own words, she was shocked at the difficulty in registering to vote in the State of Florida. She quickly became involved in the Amendment 4 campaign, which allowed ex-offenders to vote if all their associated fines have been paid. She joined PERC, the Pinellas Ex-Offender Reentry Coalition and began to teach classes about voting rights, voting eligibility and voter registration to marginalized populations. She also expanded her work in advocating for voting rights to high school students, and by going into alternative high schools to bring voting information and civics instruction to students who will be eligible to vote at age 18. She has encouraged students to pre-register to vote at 16 but has been dismayed by the lack of follow-up by the SOE in tracking these preregistrations. She found that a similar situation exists at the Division of Motor Vehicles, because there are no protections that guarantee voter registrations taken there are processed.

In 2021, Karen served on the Pinellas County Redistricting Commission, which was responsible for drawing voter district maps for the county. Karen, who has a PhD in Geographic Information Systems, was the only one on the committee who had experience in digital mapping, which includes cross-referencing maps with census data. As part of the committee, she was able to make a vital correction, when a boundary change was recommended that would have excluded a sitting commissioner from running for re-election in her own district.

When not working for her church and her community, Karen has discovered a new “later in life” passion: playing the saxophone. She is delighted that she has learned to read music and now plays with the Pinellas Community Band. Another new joy is her two-and-a-half-year-old grandson, who spends time with her each week. And as you can see from her picture...this Grandma has style!

Tuesday, January 10, 2023:

The day is here. We have been planning this for several months, actually for three years. First it was just a musing of five aging women joined together across the country in an amazing race book club. We were studying the why's and how's of the racial history of our country, searching for ways we could join in the current struggle for racial justice. Originally larger, we ended up being a group of 5 white women.

Landing in Atlanta, we quickly found our rental car. Our first stop is Centennial (1996) Olympic Park home of the Georgia Aquarium, World of Coca-Cola Exhibit and the Civil Rights and Human Rights Museum, which is our destination. We later learn that the head of Coca-Cola was instrumental in bringing the Atlanta community, white and Black, together to celebrate Dr. Martin Luther King Jr's Nobel Peace Prize. When whites had decided not to attend the ceremony, his persistence brought the communities together.

The Civil Rights and Human Rights Museum is emotionally difficult to view. We found this in many of the sites we were to visit. Our racial history tears at the heart when witnessing the death and destruction of many in Black America and the hatred expressed by the whites. This history begins with a series of multi-photos on two facing walls with pictures from Black history in the 60's and counter poses pictures of whites from the same time period. Through photos, videos and writings we are taken through the turbulent 60's, the freedom riders, Martin Luther King, Jr. and his organization as well as the myriad of groups and individuals fighting for civil rights. It was very impactful but difficult to see how horrible humans can be to fellow humans. An experiential mock lunch counter where we sit with headphones listening to the hatred being spewed by angry whites behind us is so frightening. In all, an amazing exhibit, and though the outcome is positive in the end, the suffering that Blacks (and their supporters) in this country survived is incomprehensible. And we are still not a free country for many. *(To be continued....)*
