LWVNPC Annual Luncheon, April 13, 2024 Keynote Speaker: Kevin Hendrick, Superintendent Pinellas County Schools

Forty people attended the Annual Luncheon and Business Meeting at Trinity Presbyterian Church in Clearwater. Superintendent Kevin Hendrick gave an thorough overview of what is going on in Pinellas County schools today. A key concern discussed by Superintendent Hendrick is one shared in many educational settings: student disengagement after Covid. During the pandemic, students became accustomed to remote learning. They began to doubt the value of on-site attendance, and overall school attendance rates decreased throughout the state. Superintendent Hendrick spoke of the need to motivate students to attend school by offering educational activities

that were also fun and exciting. He gave examples such as field trips, academic competitions, student leadership opportunities, athletics, and performing arts.

In addition to Superintendent Henrick's address, new LWVNPC Officers and Board of Directors were installed. Outgoing president Marti Folwell's unwavering commitment and work for the mission of the League of Women Voters is a shining example to us all. She has been a member of LWV for more than 50 years and has served as president for 4 nonconsecutive terms.

# **Important News: Change in Dues Structure!**

LWV is switching to a new member portal for all Leagues across the country. There is no action that members need to take right now, but we want to provide you with an overview of what these changes will mean for you.

This year, you will still renew in the usual way. When the system launches in January 2025, you will receive an email to log in to the portal, but you will not be asked to renew again until a year after your most recent renewal. You will be given the option to sign up to auto-renew annually, and your membership will last a year after your last renewal. Once you have access to the portal, you will be able to update your own information, including contact information.

When it comes time to renew, you will receive an email reminder. Dues will no longer be a fixed rate but will be pay-what-you-can. The recommended dues amount for all members across the country will be \$75, but members can pay any amount (min. \$20), including the current dues rate.

Under the current system, LWV of North Pinellas County pays a fixed rate per member to LWVFL and to LWVUS. Under the new system, a percentage of dues will go to the state and national League. This means that when you renew, if you would like to make an additional contribution directly to LWV of North Pinellas as some members choose to do when they renew, this will need to be separate from choosing a higher dues amount. A higher dues amount benefits the League as a whole and allows us to offer the option of lower dues to increase our member base but does not exclusively support the local League.

There will still be the option to renew by check for members who don't use the internet, but members who are able to access the portal and renew that way are encouraged to do so.

On a member level, we hope these changes will make managing your membership easier. On a League level, this is expected to increase membership around the country and increase our ability to empower voters and defend democracy. We will keep you informed as we receive new and relevant information.

#### Young Adult Focus Group via Zoom, March 7, 2024



On March 7, 2024 Jacqui Farrell, Tanya Landry, and Gayla Larson met with seven young voters via Zoom and with two individuals in calls outside of the Zoom session. Participants were in the 18- to 34-year-old age range, of varied race, gender, and ethnicity. They were homogenous in that all had college degrees or some college. This is what they told us:

They all planned to vote, even though they had peers who were not going to vote. This focus group ranked where they got information on issues and how to vote:

Our focus group reported that they all received voter education in high school, but felt it was cursory, and that little information was presented on legislative processes.

They had a slight preference for mail-in ballots. Focus group members commented that mail-in ballots gave them time to look at choices and research candidates.

These young adults were knowledgeable and motivated. We learned from them that we need to reach out to young adults in more challenging populations, such as those not attending college or just entering community college. We need to promote <a href="Vote411.org">Vote411.org</a> (the League's voter resource site) since they report doing online election research but had no idea how much time Vote411.org could save them. Two key issues are important to young people this fall: legalizing marijuana and protecting abortion. We need young voters to know their vote is critical and where they can educate themselves about the issues. We also need to continue spreading the word about the need to re-register for mail-in ballots in Florida.

# In case you missed it... Disinformation during Elections

How do we protect ourselves from *Artificial Intelligence* interfering with our elections? The Brookings Institute recently held a forum including Shana Broussard, Commissioner of the Federal Election Commission. The 2020 election was decided in a handful of states by fewer than 50,000 votes--a reason for concern in 2024. The first amendment is the 'buzz saw' that makes monitoring disinformation enforcement difficult. Tech companies

could be required to have digital water marks on their AI, but people don't pay attention to disclaimers, and this would not cover outside threats. If civil rights are abused by AI, the culprits could be prosecuted but the concern is that Black voters would be discouraged from going to the polls. The best protection is <u>education</u> on how to identify AI, with particular focus on young people. #### 7 Electoral College myths, a deeper dive

The Electoral College is not the major reason why the outcome of an election may not reflect the wishes of the American people. As many as 30% of eligible voters are not even registered, and of those who do register, only about two-thirds can be counted on to vote. For tens of millions of Americans, Election Day is a workday, not a national holiday. Our major political parties rely on primaries, caucuses and other methods that often favor the more extreme base than the middle-of-the-road Democrat or Republican. On February 29<sup>th</sup>, they hosted a table outside the Department of Health-Pinellas Mid County on Ulmerton Road, Largo, where they provided important information about mail-in ballots and rights of returning citizens. They also assisted voters in checking their voter registration and mail-in ballot status.

# **Education Committee**



The Education Committee met virtually on Monday, February 26, 2024, at 4:30 pm. Items discussed included the ongoing virtual mentoring project with the Take Stock in Children program, the newly formed Young Adult Voting Focus Group that has been organized by Jacqui Farrell, Tanya Landry, and Gayla Larson, and the Leon County video competition for high school students on the topic of voting.

Jeanne Reynolds attended the February 13th School Board

meeting as a representative of LWVNPC. She shared the following observations from this meeting: the meeting agenda was followed without any challenges. Results of the Social Studies instructional materials (textbook) selection committee were discussed. Martin Shapiro, Education Committee member, participated as a member of the selection committee and commented that the process went very smoothly. School Board members discussed the current Superintendent's contract and unanimously endorsed an extension. There were many expressions of confidence in his ability and performance to date from the Board members.

The LWVFL State Education Action Team is creating a School Board Candidate Assessment form. This form can be used by voters to help them determine the candidate they feel is best prepared for the position of School Board member. As soon as this form is finalized, it will be made available to local Leagues for distribution.

LWVNPC has been asked to participate in planning and hosting a Pinellas School Board Candidate forum this summer. The date is still to be determined.



Chair Linda Metzkow reported that the Voter Service committee was represented at Night at the Library on February 23<sup>rd</sup>. During the event, Linda connected with L. Josey Filler of the Community Engagement Team of the Clearwater Police, who would like to coordinate with LWVNPC.

LWVNPC Voter Services Committee member Nancy Sidrow has contacted the Pinellas County Health Department and will be having voter education and sign-up events at Largo, Clearwater, and Tarpon Springs Health Departments.

On Saturday, March 9th, Voter Service attended the Young Men's Leadership Initiative Empowerment Summit for Ages 12-18 at the Pinellas County African American History Museum in Clearwater, hoping to encourage those 16-17 years old to pre-register to vote.

On March 18th, Heidi Davis Vote411 trainer for Florida, was the guest speaker at the LWVNPC Voter Services Committee Meeting.

Good news! The LWVFL Board voted to absorb the entire cost of individual chapters for 2024 Vote411 and LWVNPC will not need to contribute \$75.00 to LWVSPA for one half of the 2024 cost.

Voter Services member Diana Carsey is assisting with the statewide campaign to research names of returning citizens in order to send them postcards with voter information.



Chair Bryan Beckman reported that the recent Hot Topic was very successful, and Haley Busch presented the pending legislation well. It was suggested that we establish a monthly calendar of Hot Topics going forward.



## **Spotlight: Introducing Dennis McDermott**





Dennis McDermott has recently joined the LWVNPC board of directors as Co-Treasurer and has already been instrumental in making some smart financial decisions regarding our assets.

Dennis comes from Buffalo, New York, and attended the University of Buffalo (UB), where he graduated with a degree in Geography. Early in his career, he began to consider the question, "Why do some cities flourish and others not?" Within the next 10 years, he returned to UB, this time earning an MBA in Finance and Marketing. He spent the majority of his career working with JP Morgan Chase, where he was involved in a broad range of community economic development projects in the Northeast. The focus was often on adapting existing properties to new uses. He came to believe that a necessary element of successful community development is an efficient transportation system, something he feels is lacking in affordable housing considerations for the North Pinellas area

While working with JP Morgan Chase in White Plains, New York, Dennis was also involved in Corporate Social Responsibility Programs, and it was here he became familiar with the local League of Women Voters. JP Morgan Chase became a sponsor of the local Voter Guide. Dennis reports that he got to know some great people through the League and developed a respect for the organization.


After retiring from a thirty-year career with JP Morgan Chase in 2014, Dennis moved to Clearwater in 2016. In 2020, he again noticed the League of Women Voters of North Pinellas, when LWVNPC opposed a referendum converting the Landings Golf Course to a light industrial area. LWVNPC joined with Keep Keene Green, Suncoast Sierra Club, Clearwater Neighborhoods Coalition and the Clearwater Environmental Advisory Board to educate the public and the referendum was defeated. In Dennis' words, good things happen when organizations "bring likeminded people together, tell them what's going on, and make some noise."

When he's not supporting the League, Dennis looks forward to trips to Alaska to see family, fish, fly on a float plane, and eat delicious freshly caught seafood.

#### **Sketches of Florida: Voting**

While still dark, I made my way over to the Palm Harbor Community Center wearing a fleece pullover and carrying a cooler of apples, nuts, a sandwich, and yogurt. It was going to be a long day. Polls are open today from 7 am to 7 pm for the Republican Presidential Preference primary. And even though all but one candidate had pulled out of the race, all Republican hopefuls are on the ballot: Trump, Haley, DeSantis, Christie, Ramaswamy, Binkley, Hutchinson.



That day only 140 Republican voters came in to vote, plus some confused No Party
Affiliation (NPAs) and registered Democrats—not realizing it was a closed primary for Republicans only. Some walked in with mail-in ballots thinking they could drop off their ballots (they couldn't). Early Voting Drop Boxes were only available up until the day *before* Election Day. If they wanted to vote on Election Day, they had to have their mail-in ballot cancelled and then they were allowed to vote (after having their photo ID verified and their registration checked). If they had brought a spouse's ballot to drop off, that ballot could not be received. Several were also at the wrong voting precinct: the Community Center might have been where they voted before, but precinct lines had changed, and they needed to go to their current precinct if they wanted to vote.

The EVID machines we used to verify registration and ID were efficient, but I was surprised that the next step for the voter was to pick up a paper ballot and pen, step over to a privacy station and fill in their ballot. The last step was to feed their paper ballot into an optical scanner, a kind of lock box for their paper ballot (ballots are kept for at least 22 months after an election cycle).

Election security was on the minds of several voters that day. They wanted to know what kind of ID we require, what kinds of machines we use, and how they could trust that their vote will be counted. The 2020 election still seemed to be on their minds—even though the Heritage Foundation found only ten cases of election fraud in Florida in 2023 (and many of those involved returning citizens who were confused over whether or not they had the right to vote).

By the end of the day, I thought about how Florida could simplify their voting system. For instance, why not accept all mail-in ballots on Election Day and consider them as provisional ballots for a final vote count after Election Day? Why not let people vote at the "wrong" polling place and consider their ballots as provisional to be counted after Election Day rather than sending them away and hoping they have the time to get to the correct polling place. How could signage be improved for Early Voting and drop boxes? How can messaging be improved so that voters get an email or a new voter registration card with their new polling place when they move? How can potential voters be reminded that the last day to register for the 2024 General Election is October 7, 2024? How can the Board of Elections remind voters that they have to request a mail-in ballot *every* election cycle and that they will not automatically receive one like they have in years past?

After a long day it was also clear to me that election staff and volunteers take pride in their work and are committed to election integrity and efficiency. I am also impressed by how Florida is one of only 18 states and the District of Columbia that allows 16–17-year-olds to pre-register to vote. Signed into law in 2007 to encourage younger voter participation, pre-registration can happen when applying for a driver's license or by applying online. Then those

who turn 18 on or before election day will be automatically registered to vote (with their voter registration activated 30 days before the election). Imagine if high schools across our county and our state made pre-registering to vote a graduation requirement, underscoring the importance of voting and cultivating a new generation of leadership.
